APPLICATION of a widow of a Soldier, Sailor, or Marine of the late Confederacy under acts approved March 26, 1928, and March 10, 1929, as amended by an act approved March 24, 1930.

I, Mrs. Annie L. Bryant do hereby apply for a pension under the provisions of the acts of the General Assembly of Virginia relating to Confederate pensions.

I do solemnly swear that I am a citizen of the State of Virginia and that I have been an actual resident of the said State for one year next preceding the date of this application, and that I am the widow of Albert D. Bryant who was a soldier (sailor or marine) in the service of the Confederate States in the War Between the States, and that I was married to him.

(See note below) and to the best of my knowledge and belief during the said war my husband was loyal and true to his duty, and never at any time deserted his command or voluntarily abandoned his post of duty in the said service, and that I was never divorced from my said husband, and that I never voluntarily abandoned him during his life, but remained his lawful wife up to the time of his death, and that I am a widow at the date of making this application, and that I am now entitled to receive a pension under the provisions of said act. I do further swear that I do not hold a

national, State or county office, which pays a salary or fees exceeding one thousand dollars (\$1,000.00) per annum, nor have I income from any and all sources whatever exceeding one thousand dollars (\$1,000.00) per annum, nor do I own in my own right, nor is there held in trust for my own benefit, estate or property, either real, personal or mixed in fee or for life, which yields a total income exceeding one thousand dollars (\$1,000.00) per annum. I do further swear that I do not receive a pension from this or any other State. I do solemnly swear that the answers given to the questions which I am required to answer in this application are true to the best of my knowledge and belief.

Any assessment of property does not affect the right to pension, but the gross income from all sources must not exceed \$1,000.00 per year. Certificates under B, C, E, not necessary if husband was pensioner.

NOTE.—Widows seventy-five years old or over can receive pension regardless of date of marriage. Widows under seventy-five years old are required to have been married prior to January 1st, 1890.
