Daughtery of the County of Hanover and State of Va^a of the other part: Witnesseth, that in consideration of the sum of one hundred dollars to them in hand paid, the said Richard Barrett & Mary P. his wife doth grant unto the said Sol. S. Daughtery & Jos. J. Daughtery a certain lot or parcel of land lying in the aforesaid County and village of Franklin Depot on the North side of Leboard & P. R.
