This Indenture made the thirteenth day of May in the seventh year of the reign of our sovereign lord George the third now King of Great Britain &c. Anno in the year of our Lord Christ one thousand seven hundred eighty seven. Between Robert Abraham of parish of No upper in the county of Mansmore of the one part of Joseph Scott of the same parish county of the other part witnesseth that the said Robt. Abraham for & in consideration of the sum of five shillings even money of Virginia to him in hand paid by the said Joseph Scott the receipt whereof the said Robt. Abraham hereby acknowledgeth and acquit & discharge the said Joseph Scott his heirs & assigns by then presents hath granted bargained sold aliened enfeoffed confirmed & by then presents doth grant bargain sell alien enfeoff confirm unto the said Joseph Scott & his heirs and assigns for ever all that tract or parcel of land situate lying & being in the parish of ~~St. Andrew~~ ^{Holloway} ~~St. Andrew~~ county of Sharnpton containing by estimation two hundred Acres of land be the same more or less & bounded according to the most known ancient & reputed bounds thereof which tract or parcel of land was conveyed to the said Robt. Abraham partly hereto in & by one certain indenture of bargain & sale bearing date the second day of August one thousand seven hundred eighty five by Sir Wm. Doddridge Scott, Richard Fuller & Wm. Long trustees appointed by decree of the county court of Isle of Wight for & behalf of the respective heirs of the six estates of Eliz. Bacon late of this county of Isle of Wight duly proved & recorded in the court of the county of Sharnpton aforesaid relation being thereto had may now fully appear together with all houses & houses edifices buildings yards gardens orchards trees ways waters watercourses profits commodities hereditaments appurtenances to the said plantation tract or parcel of land belonging or any way appertaining of the revenues of revenues remainder & remainder rents issues & profits thereof & every part of parcel thereof & all the estate right title interest property claim of claimant whatsoever of them the said Robt.
