 comprised by the oaths of John R. Chamberlaine and W<sup>m</sup> A. Hagenburg two of the  
 subscribing witnesses thereto and thereupon orders were recorded. And in the motion  
 of James W. Murphy the executor therein named who made oath and together with  
 Allen Edwards, William W. Lawrence and Edward C. Campbell his securities who  
 justified in oath as to their sufficiency entered into an acknowledgment as above  
 in the penalty of twenty eight thousand dollars conditioned according to Law.  
 Certificate is granted him for obtaining a probate of the said will in due  
 form.
